

一般提款操作程序

1. 网上下载提款单

- 请登入互联网网址 www.bocionline.com
- 请按“客户服务”
- 请按“可列印表格(PDF)”
- 请按“其他”
- 请按“提款单”
- 最后打印出来。

2. 填写提款单

请依照表格指示填上有关的个人资料及收款银行资料，签署必须跟我司记录相符。

3. 发出提款单

请将填写完成后的提款单，传真至 (852) 2185-6060，或
扫描后电邮至 service@bocigroup.com

4. 资金到账所需时间

如在办公日早上十一时前传送到我司，提款单将于当天办理。

请注意：提款至香港本地银行账户，需时一至两个工作天。

提款至海外及中国大陆银行，需时叁至五个工作天不等，视乎不同地区或收款银行网络而定。

因大陆的汇款受外汇管制的约束，中国境内之银行或会拒绝接受由香港证券公司持有之户口汇出之外币(包括港币及美金)，敬请先向阁下与银行查询是否能够由接受香港证券公司的港币/美元汇款，或可亲临香港开立个人银行账户。

5. 电汇手续费

提款至非香港本地银行账户 (含海外及中国大陆银行) 需以电汇方式处理。香港发款银行将收取电汇手续费港币二百元或美元二十五元。惟收款银行(或其代理银行)可能另收处理费用。详情请向您的银行咨询。

Withdrawal Procedure

1. Download the Withdrawal Slip

- Visit our website www.bocionline.com
- Click “Customer Service”
- Click “Printable Forms (PDF)”
- Click “Miscellaneous”
- Click “Withdrawal Slip”
- Print out the form

2. Fill Out the Withdrawal Slip

Please fill out all required personal information and details of beneficiary bank.
Sign at the bottom. Signature must be in accordance with our record.

3. Send the Withdrawal Slip

Send the completely filled and signed form by fax at (852) 2185-6060, *OR*
Scan and email the copy to service@bocigroup.com

4. Duration of Fund Transfer

Withdrawal requests will be processed in the same business day if the request is well received by BOCI before the cut-off time at 11:00a.m.

Note: Local Transfer normally takes 1 to 2 business day(s).

Telegraphic Transfer (T/T) payment to overseas or Mainland China normally takes 3 to 5 business days depending on different regions.

For fund withdrawal to Mainland China, due to policy of administration of foreign exchange by the State Administration of Foreign Exchange (SAFE) of China, banks in China may not be able to accept TT Fund from securities firms in Hong Kong. Please consult your bank before requesting for fund withdrawal from your BOCI Account,

Alternatively, you may open a personal bank account in Hong Kong, and give us instruction to make fund withdrawal to your Hong Kong local bank account.

5. Fund Transfer fees

Payments transferring to non-local bank accounts must be remitted via Telegraphic Transfer (T/T). A handling fee of **HKD200** OR **USD25** will be charged against client’s own account. Beneficiary bank may also charge additional fees. Details please refer to your beneficiary bank.
